Homeless Voucher Program

- help with housing to individuals who are working with an approved case manager at a local agency. Agency who have approved case managers to make the referral are Lutheran Family Services, Center Pointe, Cass, Cedars, Community Action and Family Service Lincoln.
- The program has 65 vouchers they can use. 20 are for single persons; non-disabled and 45 are for families; disabled persons. There is currently one opening for the family program.
- To apply applicants must first be case managed by an approved case manager, then complete an LHA application. Applicants will then present their goals for their plan to be approved by the committee. This program can last up to 5 years. Applicants are required to have monthly home visits. During the visit it will be determined if additional needs are needed to help someone remain successful in the program to avoid homelessness. If an applicant is doing well in the HVP they can apply to be in just the regular section 8 voucher program.
